These Terms of Use ("**Terms**") govern your access to and use of the website **pocketpiano.com** and any related products or services offered by **Pocketpiano SL** (CIF B66977513), a Spanish limited liability company incorporated on April 7, 2017, with registered activity in the manufacture and commercialization of electronic musical instruments and applications (CNAE 3220).

By accessing or using our website and services, you agree to be bound by these Terms and our Privacy Policy and Cookie Policy. If you do not agree, please discontinue use immediately.

## 1. Definitions

---

- "**Company**": means Pocketpiano SL, CIF B66977513.
- "**Website**": means pocketpiano.com and all its subdomains and related pages.
- "**User**" / "**you**": means any individual or entity accessing or using the Website or Services.
- "**Services**": means the products, software, applications, and any other offerings made available by the Company.

- **Returns & refunds:** Returns are accepted in accordance with our Returns Policy and applicable Spanish consumer protection law (Royal Legislative Decree 1/2007). Consumers in the EU have a 14-day right of withdrawal from the date of delivery.
